

**Booking of Glamp-cation Slot to Glamping by the Runway (referred to as the “Event”)
Terms & Conditions**

1. The Event is organised by Changi Airport Group (Singapore) Pte. Ltd. (“**CAG**”) and Glampingcity Pte Ltd (“**GC**”).
2. By participating in and/or making a booking for this Event, you agree to be bound by these Terms and Conditions (“**Conditions**”) and our Privacy Policy (available at <https://www.changiairport.com/en/privacy-policy.html>), which together constitute a binding agreement between you, CAG and GC, governing your participation in this Event.
3. In these Conditions, references to ‘we’, ‘us’ and ‘our’ mean CAG and GC, our respective subsidiaries and affiliates, as well as their directors, officers, agents and employees or independent contractors as the context requires
4. The prices for each glamp-cation slot which allows up to a maximum of a) 3 adults or b) 2 adults and 2 children, or such other capacity as may be allowed under the prevailing Safe Management Measures and regulations, to participate in one session of the Event are as follows:

5. By participating in and/or allowing a child/ward under your care (“**Participant**”) to participate, you declare that you and all Participants are in good physical health and do not have any conditions (e.g. heart, neck, leg or back problems) that may be detrimental to your or their well-being by participating, nor are you or any Participant under the influence of any alcohol or medication that may influence your or their ability to glamp, move or be mobile.
6. Booking of glamp-cation slots must be made at least **5 days in advance** from the intended date of the activity via Changi PlayPass. Booking of glamp-cation slots are on a first-come-first-serve basis and subject to availability.
7. All bookings made in relation to the Event are strictly non-exchangeable, non-refundable, non-amendable, and not for resale.
8. One (1) glamp-cation slot admits one (1) group of participants (the number of participants in each group as set out in Clause 4 of these Conditions), for a single stay on the date stipulated on the glamp-cation slot booked.
9. Participation in the Event requires the processing of each Participant’s personal data, including but not limited to full name, NRIC/Passport Number, personal mobile number, residential address and email address for the purposes of administering the Event, applying for airport pass for the Participant, matching personal data collected through this Event with other data CAG holds about the

Participant to optimise operations and services offered to the Participant through the Event and other platforms. By participating in the Event, each Participant consents to CAG's collection, use, disclosure, storage and other processing of any personal data provided in accordance with all applicable privacy laws and CAG's Privacy Policy (<https://www.changiairport.com/en/privacy-policy.html>). All required details of all Participants in the Event must be submitted at least **five (5) days** in advance for security clearance by the Airport Police for entry into the transit areas of Terminal 4 Changi Airport, where the Event is to be held.

10. By submission of the required details, the Participant(s) declare that all information submitted is complete and accurate as per the records on their identification document(s). Where the Participant is disclosing the data on behalf of another, that he or she has the authority and requisite consent to disclose to CAG the personal data which he or she provides to CAG pursuant to these Conditions. The Airport Police and CAG reserves the right to reject applications for the Event that are incomplete, inaccurate or for any other reason(s) which neither CAG nor the Airport police are at liberty to disclose.).
11. Identification document(s) must be presented at the designated reception booth for verification purposes prior to entry to the Event. CAG reserves the right to refuse entry for erroneous bookings or missing/incorrect detail(s) either on the submitted details or on the identification document(s).
12. CAG and the Airport Police reserves the right to deny entry to any Participant(s) for any inaccuracies between the submitted information and the identification document(s). In the event any Participant is denied entry to the Event, there shall strictly be no refund(s) or change of date(s) of the booked slot(s).
13. Participants are advised to proceed to the Glamp-cation Entry Points **10 (ten) minutes before their check-in time** to complete all required registration, security clearance and safety procedures. All participant(s) must be physically present at the point of check-in. Parent/Guardian/s must accompany your child/children/ward/s at the point of check-in and when returning to the glamping area.
14. In the case of no show and/or late arrival, the booked slot will be forfeited and there shall be strictly no refund(s) or change of date(s). CAG will not be liable for any of your losses or expenses due to the failure to comply with the provisions.
15. Minors below 18 years old must always be accompanied by an adult of 18 years old and above upon check-in and when moving around the glamping area. Accompanying adult must be part of the group in the booking, cleared for entry into the glamping area.
16. All glamping tents are allocated at our sole discretion and no requests for specific glamping tents or change of glamping tents allocated shall be allowed.
17. All participants are required to observe safe distancing and adhere to prevailing Safe Management Measures (including but not limited to the applicable vaccination-differentiated Safe Management Measures (“VDS”)) (at the Event site for their own safety and well-being. We reserve the right to deny entry to the Event or to request that any participant exits from the Event in the event the participant(s) fails to comply with the prevailing Safe Management Measures. In such event, there shall be no refund of any activity passes purchased or replacement of any activity passes redeemed.

18. For the safety and well-being of all Participants, pursuant to the VDS (and/or such other prevailing safe management measures that may be imposed or varied from time to time) non-vaccinated person(s) above age 12 and/or person(s) with positive PET test status or lack thereof a negative PET test status shall be rejected entry.
19. Participants are solely responsible for the safe-keeping of their valuable items and possessions throughout the duration of the Event.
20. Participation in the Event is strictly at your own risk. Participants who are pregnant, wheelchair bound, or suffering from medical conditions are strongly advised not to participate in the Event. Participants must observe the maximum load capacity, height requirements (if any) and suitable age group for certain play elements inside the glamping area.
21. Participants must comply with the following Glamp-cation Requirements throughout their entire glamping duration:
 - (a) Wristbands issued at entry shall be kept on at all times throughout the glamping period. Guests without wristbands will have to be escorted out of the glamping ground;
 - (b) No loitering beyond the designated glamping ground;
 - (c) No smoking within the terminal; and,
 - (d) No unruly behaviour.
22. If you and/or the Participant(s):
 - (a) fail to arrive by the stipulated time at the Event's registration location and/or
 - (b) fail to obtain the security clearance by Airport Police and/or
 - (c) appear non-compliant with Glamp-cation Requirements set out above and/or unready to participate we reserve the right to:
 - reject the slot reserved for you;
 - not delay the other participants booked at the same Glamp to accommodate you and/or the Participants;
 - forfeit your booking and not to allow any rebooking of the Event for another timeslot with no refund of any fees paid for the Event.
23. Without prejudice to the generality of clause 24 below, we shall not be liable for any of your losses or expenses due to the failure to comply with these Conditions.
24. We reserve the right to refuse or terminate the participation of any Participant in the Event for any reason whatsoever, including but not limited to unsafe or unruly behaviour that may result in harm or damage to the Participant or any other persons and/or property.
25. To promote and advertise the Event, CAG reserves the right to engage authorised photographers and videographers to take photographs and/or video recordings. By participating in and allowing any Participant under your care to participate in the Event, you consent to yourself and such participant being photographed and recorded by authorised photographers and videographers as guest/customers at the Event and consent to the use of such images, films or recordings for public transmission and for the marketing and publicity materials of CAG. Further, by participating in and allowing any Participant under your care to participate in this Event and providing your personal data

and the personal data of the Participants to us, you consent to the collection, use or disclosure of the personal data of yourself and all Participants, in accordance with our Privacy Policy and the Personal Data Protection Act 2012 as updated from time to time, for CAG's reasonable business purposes including without limitation: to administer any relevant lucky draw, statistical analyses, marketing, survey participation, to ensure compliance with and to enforce these Conditions, to address queries we receive in relation to your or any participant's participation in this Event, to protect the safety and security of our staff and property, and/or to comply with applicable laws, regulations, and/or orders of court requiring disclosure of your and/or any Participant's personal data. CAG's decision on all matters relating to this Event and these Conditions is final, conclusive and binding on all.

26. To the fullest extent permitted by law: (i) CAG, its subsidiaries and affiliates, as well as their directors, officers, agents and employees shall not be responsible for any damage or personal injury to you or to any Participant in this Event, and/or loss or damage to any property sustained as a result of your or their participation in this Event, including without limitation all direct loss, indirect or consequential loss, cost and expense, or loss of profits; and (ii) By participating in and allowing your child/ward to participate in this Event, you agree to indemnify CAG, its subsidiaries and affiliates, as well as their directors, officers, agents and employees against all claims, losses, damages, costs or expenses which may be made against or suffered by CAG, its subsidiaries and affiliates, as well as their directors, officers, agents and employees, in respect of any injury (including fatal injury), loss or damage to property arising out of or in connection with your and/or any Participant's participation in this Event.
27. CAG's decision on all matters relating to the Event and its promotion is final, conclusive and binding.
28. CAG reserves the right to vary these Conditions herein at any time at its absolute discretion without notice to you, and you agree to be bound by such amended/varied Conditions.
29. These Conditions are governed by the laws of the Republic of Singapore. You hereby agree to submit to the non-exclusive jurisdiction of the Singapore courts for any dispute arising out of or in connection with these Conditions or your or your child's/ward's participation in this Event.
30. Changi Pay promotion ("this promotion"): If you are among the first 1,000 participants to register for and buy ticket(s) to Glamping by the Runway with your Mastercard credit/debit card before 5 December 2021 ("**Eligible Recipient**"), subject to the terms and conditions of this promotion herein, you will be eligible to receive a one-time Changi Pay voucher worth \$10 (the "**Gift**"). Each Eligible Recipient is eligible to receive only one Gift regardless of the number of tickets purchased and the number of transactions made. The Gift will be issued to the Eligible Recipient's Changi Pay account by 10 December 2021. To receive the Gift, the Eligible Recipient must be at least 18 years old, have successfully downloaded the iChangi mobile application and successfully activated his Changi Pay account. By registering for and buying the ticket(s) to Glamping by the Runway, the Eligible Recipient authorizes and consents to (a) CAG using the personal data collected under the Changi Pay CAG-user terms and conditions and/or other CAG-administered programmes; and (b) CAG sharing his Singapore mobile number to Liquid Group Pte. Ltd. (which is the issuer and operator of Changi Pay) for the purposes of facilitating and administering this promotion, including but not limited to the issuing of the Gift to the Eligible Recipient's Changi Pay account. If the Eligible Recipient does not sign up for and activate his Changi Pay account by 10 December 2021, his Gift shall be automatically forfeited and CAG shall be entitled to deal with the forfeited Gift in any manner in CAG's absolute discretion. The Gift is non-transferable and cannot be

exchanged (whether wholly or partly) for cash, credit and/or other items. Gift terms and conditions apply.
