

# Jewel Changi Airport's "Weekday 1-for-1 F&B Deals" Promotion (the "Promotion")

### **Terms and Conditions**

Promotion is valid 3- 20 May 2021 (Mondays - Thursdays), unless otherwise stated and while stocks last.

#### (1) Weekday 1-For- F&B Deals

- Enjoy 1-for-1 on selected items at more than 30 participating F&B outlets from Mondays to Thursdays, excluding the public holiday on 13 May 2021.
- Complimentary items may be of equal or lesser value than the paid item.
